- Advanced practice level in, assessment, treatment, service coordination and, as required, urgent response to the most complex clients, frequently with co-occurring disorders, who may also have serious functional impairment in the domains of physical health and personal, family, school, and social life.

- Ability to handle crisis and participate in crisis intervention assistance.
